WE TRY NOT TO STACK SAME SELLING TYPE VENDORS FOR THE EVENT, SO THAT EVERYONE HAS A FAIR CHANCE IN PROFITS, AT THIS TIME AS WE ARE GROWING. LATER DATE THIS COULD CHANGE TO BENEFIT PARTICIPANTS AND PUBLIC. **WE HAVE INDOOR & OUTDOOR SPACES AVAILABLE!**

**FOR THOSE VENDORS REQUIRING WATER IT IS AN ADDITIONAL \$15 & FOR ELECTRICITY AN ADDITIONAL \$25. (Pertains mostly to FOOD VENDORS)**

EVERYTHING YOU BRING MUST FIT INSIDE YOUR SPACE, INCLUDING DISPLAY STANDS, TRAILER TOUNGES, AWNINGS, TABLES, ETC. NOTHING WILL BE ALLOWED IN THE AISLES. WE ASK IF YOU HAVE WATER OR ELECTRICITY (GENERATORS) THAT YOU PLEASE BRING THOSE. IF ELECTRIC IS REQUIRED PLEASE LET US KNOW IN ADVANCE WHAT WATTAGE IS NEEDED.

SETUP WILL START AT 9:00AM -5:00PM FRIDAY AT THE LOCATION & ALSO 7:00AM – 9:00AM SATURDAY AT THE LOCATION OF EVENT- **Titus County Civic Center, Mount Pleasant, TX.** THE LOGISTICS COORDINATORS ALONG WITH RALLY COORDINATORS WILL BE PRESENT TO HELP WITH DIRECTING VENDORS. THIS WILL HELP WITH LESS CHAOS OF VEHICLES AT SITE OF UNLOADING, ETC. THE COORDINATORS WILL ALSO BE THEIR TO HELP WITH ANY LAST MINUTE QUESTIONS, CONCERNS, ETC. WE WILL PUBLISH A SCHEDULE WITH TIMES FOR OPENING AND CLOSING OF THE RALLY AREA. VENDORS DO HAVE PERMISSION TO TEAR DOWN SATURDAY EVENING, BEFORE ENDING CONCERT OR AFTER, IF ANY HELP IS REQUIRED GET WITH A STAFF MEMBER OF EVENT, AND BE COURTEOUS TO REMAINDER OF EVENT GOING ON WHILE YOU TEAR DOWN. EACH VENDOR SPACE COMES WITH TWO RALLY PASSES. IF YOU REQUIRE ADDITIONAL PASSES THEY CAN BE PURCHASED ON SITE.

QUESTIONS SHOULD BE DIRECTED TO ME. IF I DON'T KNOW THE ANSWER I WILL MAKE EVERY EFFORT TO FIND ONE. MY CONTACT INFORMATION IS LISTED BELOW. E-MAIL ME ANY TIME. I CHECK IT DAILY. PHONE CALLS ARE BEST DURING THE LATER AFTERNOON/EVENING. OH YEAH, ONE MORE RULE, I HAVE FINAL SAY AS TO WHO IS AT THIS EVENT AS A VENDOR AND I TRY HARD TO MAKE EVERYONE HAPPY. DO NOT BE UNPLEASANT TO ME!!!

## **INSURANCE, ADDITIONAL REQUESTS:**

SOME VENDORS WILL BE REQUIRED TO HAVE LIABILITY INSURANCE. VENDORS THAT PREFORM ANY TYPE OF WORK ON A MOTORCYCLE OR SELL MOTORCYCLE PARTS OR ACCESSORIES ARE REQUIRED TO PROVIDE PROOF OF LIABILITY INSURANCE. OUR INSURANCE POLICY DOES NOT COVER YOU!!! YOU MUST HAVE SOME KIND OF LIABILITY INSURANCE.

**FOOD VENDORS PLEASE BE SURE TO HAVE PERMITS TO DATE, UP TO CODE FIRE EXTENGUISHERS, THOSE THAT FRY FOOD YOU NEED A TYPE K EXTINGUISHER, ETC. THE HEALTH INSPECTOR AS WELL AS FIRE MARSHALL WILL BE CHECKING THESE FRIDAY EVENING OR SATURDAY MORNING BEFORE EVENT BEGINS**

## **TAXES:**

PAYMENT OF STATE SALES TAX IS REQUIRED IN TEXAS. YOU WILL BE RESPONSIBLE FOR COLLECTION AND REPORTING OF SALES TAX. TEXAS REVENUE DEPARTMENT MONITORS THIS TYPE EVENT TO INSURE ALL PARTICIPANTS COMPLY. TEXAS MOTOR VEHICLE DEPARTMENT PROHIBITS THE SALE OF ANY VEHICLE BY PERSONS NOT LICENSED AND IN COMPLIANCE WITH TEXAS LAWS. DISPLAY AND DEMONSTRATION OF VEHICLES IS PERMITTED. THE SALE OF TRAILERS IS NOT REGULATED BY THE STATE. THE SALE OF CUSTOM BUILT MOTORCYCLES IS PERMITTED AT THIS TIME AND NOT REGULATED BY STATE LAW. PLEASE CHECK WITH ME IF YOU INTEND TO SELL THIS TYPE OF VEHICLE TO INSURE THAT IT QUALIFIES UNDER STATE LAW. SUBLETTING THE SPACE OR ANY PORTION OF THE SPACE IS NOT ALLOWED, ALL VENDORS MUST BE REGISTERED AS VENDORS AND HAVE INSURANCE. NO EXCLUSIVES WILL BE INTENTIONALLY ALLOWED BY THE EVENT. WE ENCOURAGE COMPETITION BUT WILL STRIVE NOT TO HAVE TOO MANY VENDORS OF ONE TYPE.

DAWG FEST PROHIBITS FIREARMS, CONTROLLED SUBSTANCES (YOU KNOW, DRUGS), PORNOGRAPHY, ETC. THESE ARE NOT ALLOWED, AND WHILE WE MAY OR MAY NOT LIKE THEM THEY ARE NOT ALLOWED, OR FOR SALE ON SITE. IF YOU DO NOT FOLLOW THESE GUIDELINES YOU WILL BE ASKED TO REMOVE THE ITEMS OR LEAVE THE PREMISES. ROBERT ARELLANO DAWG FEST LOGO, NAME AND ARTWORK ARE PROTECTED AND NOT ALLOWED TO BE USED BY VENDORS WITHOUT A LICENSE AGREEMENT. DELIVERIES TO THE SITE MUST BE ARRANGED WITH THE EVENT. THE EVENT OR ITS EMPLOYEES WILL NOT ACCEPT OR BE RESPONSIBLE FOR YOUR MERCHANDISE.
